

Visitor Policy

Dear Visitors!

Please respect the following rules during your visit at the Exhibition Centre (the building and the TÜRBE Garden):

All vehicles, such as bicycles, scooters, animals (except guide dogs), stabbing and cutting tools or hazardous materials or anything that may pose a risk to the safety or health of the exhibits, other visitors and staff are NOT PERMITTED IN THE EXHIBITION GROUNDS (IN THE BUILDING AND IN THE GARDEN). It is prohibited **to step on the grass or to consume food or drink** in the Garden. Strictly for health reasons, visitors may be brought into the Exhibition Grounds one bottle of non-alcoholic drink in a bottle of up to 0.5 litre capacity, but may only be consumed outside the Exhibition Grounds.

Persons under the influence of alcohol, intoxicants or stimulants, persons with fever or infectious diseases, or persons arriving in inappropriate clothing or inadequate to the spirit of the Exhibition are NOT PERMITTED TO VISIT the Exhibition Grounds. Security guards are authorised to take measures against any person whose behaviour is prejudicial to or endangers the safety of visitors, staff or the safety of the Exhibition Centre or its installations or otherwise causes offence.

The requests and instructions of security guards, hall attendants and staff of the Exhibition Centre must be complied with in all cases. The security guards, hall attendants and staff of the Exhibition Centre are entitled, in accordance with the legislation in force, to ask visitors entering the Exhibition Centre for certify of their eligibility for entry, and in case of refusal of which they are entitled to prohibit the visitor from entering.

SMOKING (including electronic cigarettes) IS PROHIBITED on the premises of the Exhibition Centre. Smoking is possible only outside the main entrance barrier, at least 5 metres from the entrance.

PROTECTION OF ARTWORKS: Even mild touching can cause damage to artworks. Please keep a distance of at least 30 cm from the artworks on display, as marked on the floor in some places, and do not touch any of them, including stonework. It is forbidden to climb over the guard rails, to enter areas closed to visitors and to stay in closed areas without permission! It is forbidden to bring food, drink, children's toys or any device or objects that may endanger the artworks into the exhibition area.

The Exhibitor may claim compensation for the damage caused by the deliberate or negligent behaviour of a visitor or initiate compensation proceedings against him/her. The Exhibitor shall not be liable for any damage caused by visitors to third parties.

CLOSING TIME: Closing of the exhibition grounds begins at 5.45 pm. Visitors are kindly asked to leave the Exhibition Grounds and the Garden until closing at 6 pm.

CELL PHONES: Please do not disturb other visitors in the exhibition area by talking loudly, and please mute your cell phone.

VISITING WITH CHILDREN: Our Exhibition Centre happily welcomes young visitors, meanwhile for safety and security reasons, the following rules shall be followed:

Children below the age of 2 may only be taken in the exhibition area in strollers or in front-facing baby carriers. Carrying babies in the neck or on the back is not permitted for reasons of artifact safety. The stroller may only be pushed and may not be carried folded in the hand.

Children under the age of 14 should visit the exhibition area under adult supervision. Parents, caregivers, or guardians are responsible for child supervision and to ensure the protection of artworks, exhibition halls and any property, as well as for the physical safety and the behaviour of the minor within the Exhibition Grounds. Please be considerate of other visitors during your visit to the Exhibition Centre.

TOUR GUIDE: Guided tours are available by requested for a fee at info@gulbabaalapitvany.hu email address.

VISITING WITH A GROUP OR FAMILY: The group leaders, accompanying teachers and parents (or freelancer guides with a special permit) are responsible to ensure that all group members or children comply with the Visitor Policy.

Please send your request for a group visits or guided tours to info@gulbabaalapitvany.hu at least 1 week before the event.

PHOTOGRAPHY AND VIDEO: Visitors are allowed to take photographs and record videos without using flash, tripods or selfie sticks. Photograph and video recording may be used for personal use only and may not be used for commercial purposes. In certain temporary exhibitions, recordings can be restricted.

Please send your request permission for commercial photography and filming to info@gulbabaalapitvany.hu at least 1 week before the event.

The Exhibitor shall make the entry into the Exhibition Centre and visits to the building and the Garden subject to acceptance of and compliance with the Visitor Policy, which shall be binding on all visitors. In the case of visitors who do not comply with or do not respect the provisions of the Visitor Policy may be refused access to the Exhibition Centre and may be removed from the building and the Garden with the assistance of security guards.
